Commercial Property Finance

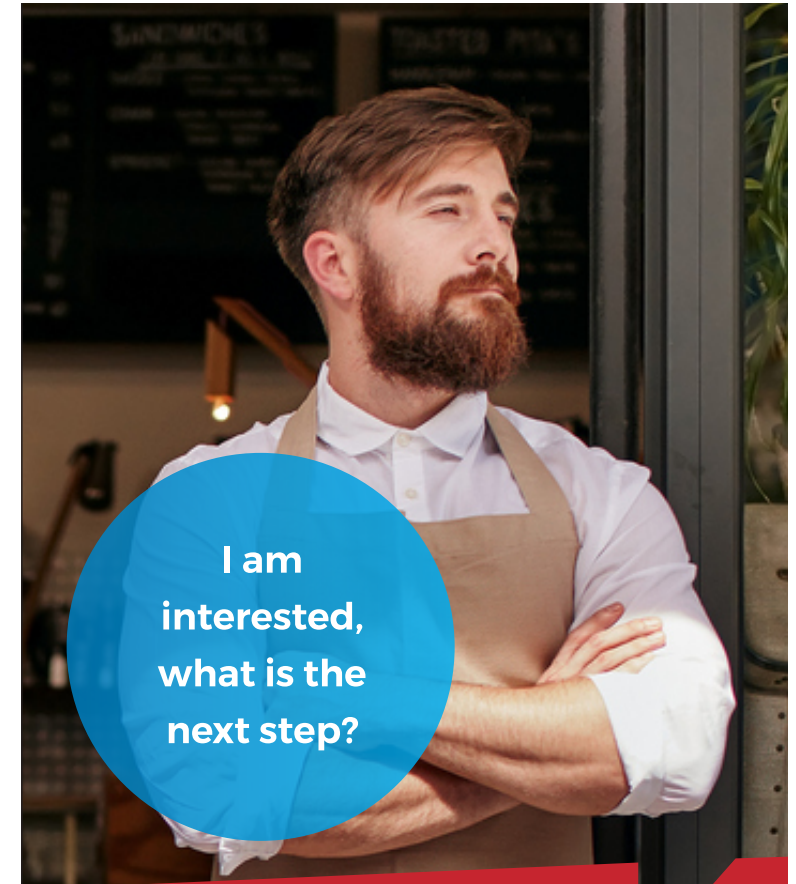
